This Deposit Contract, when signed by both parties represents:

- 1. Buyers** promise to buy a puppy from Marsh's MAS current litter(s).
- 2. Breeders** promise to hold a suitable puppy, as described within this Contract, until the puppy reaches 10 weeks of age or when specifically written here or in a Flight Agreement.
- 3. The Buyer** understands that this Deposit Contract is the **Buyer** making a commitment to a puppy for their entire life. The deposit is only refundable if the puppy develops a health issue that would prevent the dog from having a quality life or from doing the job intended for them. If the **Buyer** chooses not to go through with the final sale, for any other reason, all monies will be transferred to the next available litter.
- 4. The Breeder** reserves the right to Not place any puppy with the **Buyer**, should the **Breeder** feel that the **Buyer** can no longer provide a suitable home for an available puppy at this time. The **Breeder** will then return ALL monies to the **Buyer** with a written explanation for refusal.

8. If a specific need is not written here in this contract, it will not be taken into consideration and does not warrant turning a puppy away in order to wait for another selection. If the **Buyer** specifies that they only want a specific thing like “blue eyes” and the **Breeder** does not have a puppy to match, then the **Buyers** deposit will move to the **Breeders** next available litter. No monies will be refunded.

9. If at any time during the puppies development, the **Buyer** wants to change their specific request, the **Breeder** will gladly alter any paperwork until the puppy(s) reach 8 weeks old.

10. The **Buyer** agrees and accepts that no one specific puppy will be guaranteed to the Buyer until all health testing and evaluations are completed (between 8-9 weeks of age).

11. The **Buyer** agrees and accepts that no puppy leaves the **Breeders** home before 9 weeks of age, 10 weeks of age if being shipped via air.

12. The **Buyer** agrees to have read, understood and agreed to all aspects and conditions of this agreement to its full entirety.
