This Deposit Contract, when signed by both parties represents:

1. The **Buyers** promise to buy a puppy from Marsh's MAS current litter.
2. The **Breeders** promise to hold a suitable puppy, as described within this contract until pick up date, stated within this contract or until the end of departure week in a shipping contract.
3. If further arrangements for the dog's departure have not been made in writing by 9 weeks old, the dog will go back up for sale. The **Buyer** forfeits their deposit and this contract is terminated.
4. The deposit is refundable if the selected puppy(s) is diagnosed with a health issue that would prevent the dog from having a quality life or from doing the job intended for them. Health evaluations are completed by 9 weeks old. If the **Buyer** chooses not to go through with the final sale for any other reason, the **Buyer** forfeits their deposit and this contract is terminated.
5. The **Breeder** reserves the right to Not place any puppy with the **Buyer**, should the **Breeder** feel that the **Buyer** can no longer provide a suitable home for an available puppy at this time. The **Breeder** will then return ALL monies to the **Buyer** including any shipping deposit with a written explanation for refusal.

8. The **Buyer** agrees and accepts that no one specific puppy will be guaranteed to the Buyer until all evaluations are completed (between 8-9 weeks of age).

10. Based on final evaluations, the **Breeder** reserves the right to keep any puppy for their breeding program. If that puppy was reserved to a **Buyer** and there is no replacement available, the **Breeder** will return all monies to the **Buyer**, including any shipping deposit.

11. The **Buyer** understands that no puppy leaves the **Breeders** home before 9 weeks of age.
